The resolutions will also be displayed on the electronic billboard screen at the National Delegates Assembly.

All resolutions will be reviewed in advance and presented to the National Delegates Assembly by the National Resolutions Committee. All resolutions must contain the estimated cost to implement the first year and each year thereafter. Resolutions are not constitutional amendments. Constitutional amendments are done through a separate requirement process. All resolutions acted upon by the National Delegates Assembly, along with the action taken, will be published in the National President's Annual Report.
