Eddie Lee Carter

1923 - April 6, 2020 Life member, Albany Area Chapter, Region IV

Mr. Eddie Lee Carter, Jr. was a native of Albany, GA. He was educated in the public schools of Dougherty County. While in high school, he enlisted in the Navy and retired in 1964 after serving 24 years and achieving the rank of Chief Petty Officer. In 1964, he returned to Albany and began his life as a civilian, working at Union Dry Cleaners with his brother, Andrew J. Carter; then as the Chief of Security at Albany State (GA) University, and then as Security Officer at the U.S. Marine Supply Center.

In 1968, Mr. Carter opened the first location of Carter's Grill on the corner of Gordon and Jefferson. This was followed by another location, Carter's Grill & Restaurant on South Jefferson/Coachmen Park, then to South Madison and finally to Highland Avenue. He joined the BIG, Albany Area Chapter on March 16, 1996 and allowed his restaurant to be a venue for chapter meetings and social events (Christmas Party and Retirement Meetings). He was very diligent about paying his dues and keeping us up to date on what was happening in the community. Retiring again in 2018 after 50 years as a business owner, he created a legacy for our chapter members about commitment and service.



Ruth Lanell Stennis Williams

March 9, 1936 -March 28, 2020 Columbus Ohio CACBIG, Region V

Ruth Lanell Stennis Williams was co-founder of CACBIG. She has served as President, Vice- President, Secretary, and Treasurer. Mrs. Williams was born in Columbia, Mississippi on March 9, 1936. She earned a Master of Public Administration from Central Michigan University while maintaining a job and a family. She earned a B.S. degree in Biology Education from Jackson State University during a time when very few Blacks were completing high school, much less attaining advanced degrees.

Ruth retired from the federal government after 42 years of service. She began as a computer systems trainee for the former Defense Construction Supply Center, working as a mainframe computer programmer. She finished her service as a computer specialist with Defense Logistics Agency (DLA), where she was the project manager for one of the first telecommunication networks in the agency. In addition to being co-founder of the DLA chapter, Ruth was involved in a number of civic organizations, including La Leche League, Toastmasters, Alpha Kappa Alpha Sorority, Inc., St. Philip Episcopal Church Women, and St. Philip Episcopal Church Altar Guild.

Ruth loved all kinds of music; she and Homer had an extensive record collection covering almost all genres. She and Homer also loved to travel; in their time together, they visited Morocco and Canada. They also drove across the U.S. to California and back on two separate occasions. Ruth was preceded in death by her parents, Rufus Benjamin Stennis and Julia Odessa Barnes, and a sister Shirley Pearl Floretta Stennis (Robert Williams).

Ruth leaves behind an extensive family including her husband Homer; sons, Harlan and Bretton (Stephannie); daughter, LaNelle (Mounir); nephews, Donovan Williams and Rodger Williams; grandchildren, Lavell, D'Mitri, Bretton, and Ramzy; four great grandchildren and a host of other relatives and friends.

In 2012, Mr. Leonard T. Stone was elected to BIG's Distinguished Service Hall of Fame (DSHOF), providing him with the title of "Honorable." As the highest honor awarded to any single member of BIG, DSHOF is bestowed to individuals who have distinguished themselves by making exceptional contributions at the National, Regional and Chapter levels of the organization. Hon. Stone was recognized for his outstanding dedication in the numerous positions he held while serving BIG for 37 years. His positions included: Special Advisor to the National President, National Parliamentarian, National Telecommunications Chair, National Board of

Directors Constitution and Bylaws Committee, Region V Director, and two separate four-year terms as the Greater Dayton Chapter President.

Brother Stone was a dedicated advocate within the African American community, a respected mentor to people of all ages, and subject matter expert on a myriad of issues and specialties. His life validates the foundation of excellence and opportunity for all that BIG stands. In addition, he proudly served his country with valor and distinction as a member of the United States active duty Air Force for 4 years. After 32 years as civil servant he retired from federal service at Wright-Patterson AFB as a Contract Negotiator and Procurement Analyst.

Hon. Stone was a reverent and spirit-filled man who loved the Lord. He was a devoted husband who loved his family with a gentle yet stern combination only he possessed. He was a confident counselor, a man of wisdom and grace, the loyalist of friends, and a man of God who was always available to share an encouraging word based on his wide range of expertise and life experience.

Hazel Marie Lyons was a dedicated member of the BIG Department of Labor Chapter (BIG-DOL) for more than thirty years. She was also a BIG Life Member. She retired from DOL in 2014, having served close to 43 years of honorable and devoted service to the nation. Ms. Lyons made a noteworthy impact on the history of BIG-DOL. Along with the late Mr. Earl Simpson, in 1984 she was one of the founders of the BIG-DOL Gospel Choir. The choir

rendered service at BIG-DOL and Departmental programs, church events, and many other Federal government agencies. The choir was also the impetus for organizing the National BIG Gospel Choir, which performs at the annual BIG National Training Conference (NTC), later renamed National Training Institute (NTI). Furthermore, Ms. Lyons was one of the founders of the BIG-DOL Annual Juneteenth Celebration and Cookout, which celebrated the late notice to slaves that they were set free in Texas. She also established BIG-DOL African American Harvest Week activities that the chapter held each year in October, where the activities, which included programs and food-tastings, celebrated our heritage and the fruits of our labor. Ms. Lyons also served as an Independent Board Member of BIG-DOL.

Ms. Lyons also made long-standing contributions for the betterment of all DOL employees as a member of the American Federation of Government Employees (AFGE)-Local 12. She served as a Steward and as the Assistant Treasurer of Local 12. Ms. Lyons was a vital and indispensable member of the leadership executive board team that performed hard-won 1980 contract negotiations with the Department of Labor. The DOL/Local 12 contract was considered the best-ever negotiated for federal employees in the United States of America. Major revolutionary gains were made for employees, which included flexible hours of work; maternity, paternity, and child-rearing leave; annual and sick leave; training and promotions; layoffs (RIFs); terminations and suspensions, and performance appraisals.

An advocate for community activism, Ms. Lyons volunteered for the NAACP, the Urban League, and other grass-roots organizations. Indeed, Ms. Lyons steadfastly and lovingly served BIG, the Department of Labor, and the African American community.



Hon. Cassandra Jones

April 2, 1958 - February 22, 2020 Founding Member, UMOJA Chapter, Region XI

Cassandra Denise Jones was born in Fitzgerald, GA on April 2, 1958 to the late Oleon Jones Sr. and Jacqueline Faye Jones. Cassandra received her education in the public schools of the District of Columbia and received two Associate Degrees in Applied Science & Computer Accounting Technology, from Strayer University. In 2004 she received her Bachelor of Science Degree in Accounting from the University of District of Columbia. She worked as Finance Resource/Budget Office Manager for the Central Intelligence Agency and retired in 2013 after 37 years of federal government service. She received numerous

awards of service and recognition from the Agency.

A Life member, Cassandra, joined BIG in 1991 as a founding member of Region XI, UMOJA Chapter. She was a highly esteemed member for more than 26 years for her demonstrated enduring commitment and dedication to the goals and objectives and guiding principles of the organization. Serving BIG in numerous capacities at the National, Regional, and Chapter levels, she had many accomplishments to her credit. Her involvement in BIG at the National level began in 1997, first as the NTC Pre-Registration Chairperson, and then in 1999 as the Database Oversight Monitoring Chairperson.

For years, students were afforded the opportunity to fulfill a portion of their community service requirements for graduation while performing various tasks on the Conference Registration Committee. She was a living testimony to the fact that she did more than influence change over the years, while looking ahead at emerging registration trends and the possibilities for the organization.
