The submission date is firm to enable the BIG Constitution Committee to satisfy the BIG National Constitution requirement of mailing the proposed amendments to the regions and chapters at least 60 days (**June 12, 2024**) prior to the start of the 2024 National Delegates Assembly (Policy 1:07).

In accordance with Article XV, Paragraph 3 of the BIG National Constitution, "Any member in good standing at the chapter, regional and national level may propose amendments to the National Constitution." Strongly encourage meeting with respective BIG members to receive input and participation. Your cooperation and active participation are appreciated.
